## **VLP News**

One of the most challenging problems facing civil legal aid organizations and the Courts is how to deal with litigants who must use the court system but don't have the income to hire an attorney. Despite historic low interest rates for IOLTA and limited resources, VLP has worked with area judicial officers and other partners to better serve this population in recent years. These efforts improve court efficiency by ensuring properly drafted pleadings allow matters to be prosecuted without unnecessary continuances and delays. They also relieve some of the burden on our intake systems operated by the EBA Lawyer Referral Service, the Legal Aid Society of Evansville, and Indiana Legal Services. So, when you are looking for a way to volunteer some pro bono time, you might want to consider some of these other opportunities. VLP helps operate Indiana Free Legal Answers. Take a look at the site and consider registering so you can answer questions: <a href="https://indiana.freelegalanswers.org/">https://indiana.freelegalanswers.org/</a>. We offer two monthly Talk to a Lawyer phone hotline clinics – on the first Thursday of the month at 4:30 p.m. and the third Tuesday of the month at 11:30 a.m. We also offer weekly in-person Talk to a Lawyer Clinics at the Vanderburgh County Law Library on Thursdays at 11:00 a.m. These clinics now serve approximately 35 self-represented litigants monthly. 


