With this hope however comes some dark clouds. As of the writing of this message, the eviction moratorium that has protected many low-income Hoosiers from losing their housing was scheduled to end June 30th. Similar protections for homeowners facing foreclosure are also coming to an end. None of us knows exactly what will happen next but these renters and our local courts may be facing hundreds, if not thousands, of dormant ejectments and rent and damages hearings coming back to life. To help prepare Indiana lawyers to help in this challenge, the Indiana State Bar Association recently presented a CLE on eviction law and the end of the pandemic. It can be accessed on the State Bar's CLE portal free of charge.



Spain for a time in college.


What was your first job? A paperboy for the Evansville Press.
