These efforts improve court efficiency by ensuring properly drafted pleadings, creating informed pro se litigants, and helping the public understand the justice system. They also relieve some of the burden on our intake systems operated by the EBA Lawyer Referral Service, the Legal Aid Society of Evansville, and Indiana Legal Services.

So, when you are looking for a way to volunteer some pro bono time, you might want to consider some of these other opportunities that complement case placements. You can now participate in most of these opportunities virtually, making it even easier to help.

"The name of our foundation is The John L. Sanders – Evansville Bar Foundation. It has recently come to my attention that many of our newer members have no idea who John L. Sanders was. I would like to correct that. John L. Sanders was born September 3, 1896 in Chandler, Indiana. He moved to Evansville in 1923 and established a law practice. He actively maintained that practice past the age of 100 years. Mr. Sanders always wore a suit. He drove (sometimes on the sidewalks), got around on his own, and did things on his own terms. One of his favorite sayings was 'Take good care of the body. It's just a machine to carry the head around.' In addition to practicing law, he was an avid bee keeper. At his death, Sanders' widow, Evelyn, endowed the EBA with \$1,000,000.00, which was used to form The John L. Sanders Memorial – Evansville Bar Foundation."

Over 20 years ago, Sanders' widow Evelyn gave the endowment to the EBA creating the EBF. Approximately 10 years ago, Judge Heldt wrote those words for the Summation, and they are worth repeating. Without your continued generosity, the EBF would have run dry a long time ago. To help ensure that the EBF can continue Sanders' legacy through its mission for another decade, we rely on donations from you, and while none of us may have the ability to give to the EBF to the extent that Sanders' widow, Evelyn, did, every little bit helps.
