Hard to believe that it is that time of year when we have to start closing the book on 2020 and looking forward to 2021 – especially since this year seems to have been 27 months long. As we do each year, you will find a sign-up sheet for Talk to a Lawyer at the end of this Summation. You will also find a Self-Reporting Form to report efforts you have made from sources other than VLP. For nearly twenty years, volunteers from the Evansville Bar Association – **lawyers and paralegals** – have fielded phone calls from area residents, serving over 13,000 callers during that time. Anyone can volunteer for TTAL and no previous experience is necessary. Resource materials are available and each session's volunteers often work together to help answer more challenging (or unusual) questions posed by callers. Our lunch TTAL is scheduled for the third Tuesday of each month from 11:30 to 1:00 Central Time. And, our long-standing Thursday evening session is scheduled for 4:30 to 6:00 p.m. on the first Thursday of the month. Talk to a Lawyer is one of the ways that the local bar interacts in a positive way with members of the public. This service also helps relieve some of the caller demand at our partner programs like Indiana Legal Services, the Legal Aid Society, and the EBA's Lawyer Referral Service. Volunteering is easy, fun, and there are snacks. Please consider signing up for as many dates as you can. Thank you!

As you may remember, the law library hosts legal clinics operated by the Volunteer Lawyer Program. At the end of August, the Family Law Clinic returned to its regular meeting schedule on the first and third Thursday from 11:00 a.m. to 1:00 p.m. Participants must have an appointment in advance to attend the Family Law Clinic.

For those wanting civil legal assistance through the *Pro Se* Navigation Clinic, participants have been able to come by the library since September to speak with an attorney on the second and fourth Thursday from 11:00 a.m. to 1:00 p.m. In addition, self-represented litigants facing evictions, collection matters, support modifications, or other pandemic-related issues may stop by the daily in-person help desk offered each weekday from 8:30 to 9:30 a.m. located in the Old National Events Plaza near the temporary Vanderburgh County Superior Courtrooms. The monthly "Talk to a Lawyer" (TTAL) program continues as scheduled.
