## PRESIDENT'S MESSAGE

### Paralegal Education For High School Students

At this point, many of us are familiar with the good work of the Randall T. Shepard Leadership & Law Academy. That program, based at Harrison High School, is a four-year leadership development program that integrates social studies and English curriculum for high school students that are interested in law and social justice. Many students are considering careers as attorneys. The program requires students to participate in rigorous learning activities, sets its students apart and shows that they have a commitment to learning that extends beyond traditional programs. Students coming out of the Shepard Academy are well prepared for college and beyond.



On the other hand, there appears to be a continuing demand for new paralegals as well. The Employment Opportunities section of the Summation is usually rife with job openings for paralegals. In last month's edition, half the openings were for paralegals. The challenge is to provide a path for students wanting to become paralegals to obtain the skills they will need for success.

Knowing of the need for paralegals and of the great resources at hand, a coalition of people and groups are coming together to try to establish a new paralegal program through the Evansville Vanderburgh School Corporation's Early College Program. This program allows students to earn both a high school diploma and work toward an associate's degree or certificate. Students enrolled in the new paralegal program and completing it successfully would have the opportunity to earn a certificate from Ivy Tech, while still in high school. This means that the students will be ready to hit the ground running as paralegals in the legal industry right out of high school. I know that there is considerable excitement at the Bar Association over this potential program.

Students enrolled in the program would actually take paralegal classes at Ivy Tech Community College. Our branch of Ivy Tech is one of the good things about living in Evansville. The college is committed to training its students to be ready for next level jobs. It offers both certificate and associate degree programs. It has been a great advocate for workforce training in Evansville and Southern Indiana.

One of the potential challenges to this program, though, is long term funding. Since the students will be enrolled in Ivy Tech courses, there will be tuition expense. We and others are looking for creative ways to help defer and/or subsidize these expenses. Judge Shively has been leading the charge in relation to this program on behalf of the bench and bar. You may be hearing from him as he reaches out for suggestions in relation to the program.

I would say one final thing about being in Evansville that great is our bar. When we come together we can solve problems or find solutions for just about anything. So I would ask that if Judge Shively calls, you consider how we can all help in providing a path for Evansville students to join us as paralegals.

This service also helps relieve some of the caller demand at our partner programs like Indiana Legal Services, the Legal Aid Society, and the EBA's Lawyer Referral Service. 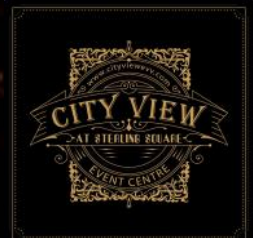

As you may remember, the law library hosts legal clinics operated by Pro Bono Indiana, Inc./Volunteer Lawyer Program of Southwestern Indiana. The Family Law Clinic meets on the first and third Thursday from 11:00 a.m. to 1:00 p.m. Participants must have an appointment in advance to attend the Family Law Clinic. The *Pro Se* Navigation Clinic meets on the second and fourth Thursday from 11:00 a.m. to 1:00 p.m. No appointment or referral is required to participate in this general clinic.

On October 1, the daily in-person help desk offered each weekday at the Old National Events Plaza moved to the law library. Pro Bono (free) attorneys continue to staff this help desk from 8:00 to 9:00 a.m. each week day to assist self-represented litigants facing evictions, collection matters, support modifications, or other pandemic-related issues. This help desk will remain open and available through Thursday, December 23, 2021.

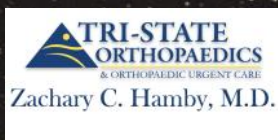

Since then, I have realized finding balance in the many categories of life is challenging. Imbalance causes all kinds of neglect, often of your own wellbeing. I've learned that balance isn't giving each area of your life an equal slice of the pie either. His advice is something I think of often and has improved my life greatly.

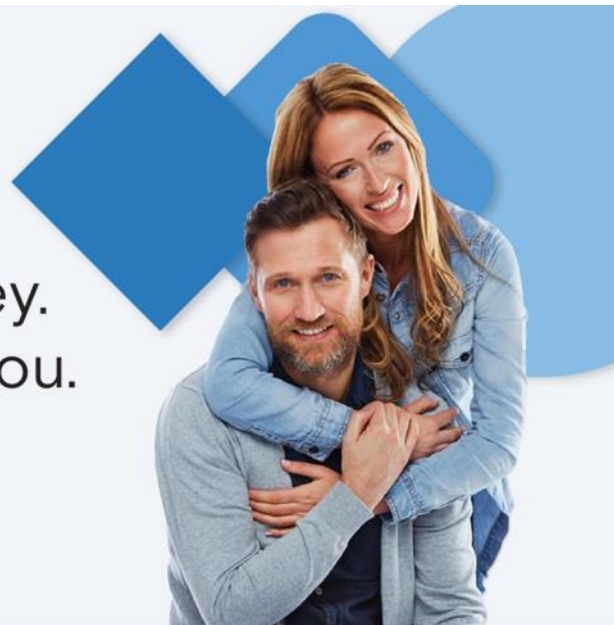
